I will keep strictly confidential and will not, without the prior written consent of the Producer, at any time from the date I sign this application form and thereafter for twelve (12) months following the first transmission on television in NAIROBI of the final episode of **TOP COMIC**, disclose, publish or reveal to any person any incident, conversation or information concerning **TOP COMIC** or the application/selection process or my appearance (if at all) in **TOP COMIC**, which comes to my knowledge as a result of my inclusion in the participant selection process and/or **TOP COMIC** (if selected) nor other information relating to the Producer, NTV, the artist management agency or **TOP COMIC** which comes to my knowledge during this period, other than information already in the public domain. Should I be approached or contacted by the press, I shall immediately refer them to the Producer's publicity officer,
15. If I am selected to participate in **TOP COMIC**, I will be required to enter into a formal written agreement with the Producer and/or any other relevant party, the terms and conditions of which will be necessary to protect the rights of the Producer, NTV and/or such other entity involved in the production of **TOP COMIC**. Should I choose not to enter into such formal written agreement, I acknowledge and agree that I will be disqualified from participating in **TOP COMIC**.

17. I have not entered into any contractual, commercial, sponsorship or other arrangements in respect of my **COMIC** performing abilities nor have I entered into or will enter into any contractual, commercial, sponsorship or other arrangement in respect of my possible appearance in **TOP COMIC**.
18. I will not engage in any photographic sessions in relation to **TOP COMIC** with any third party without the prior written consent of the Producer and NTV.
19. I warrant that I understand and accept these Application Rules, that I have no legal obligations which conflict with the making of this application in accordance with the Application Rules, and that I have the legal capacity to make this application in accordance with the Application Rules. Should I not have such legal capacity; my legal guardian/s will sign this application on my behalf. If I am under the age of 21, my legal guardian/s will sign this application on my behalf.
20. Neither the Producer nor NTV nor the artist management agency involved in **TOP COMIC** shall be liable for any damage or loss arising out of my participation in, or the performance of my obligations as a participant of **TOP COMIC**.
21. The Producer is entitled to disqualify me from **TOP COMIC**, at any time and without compensation, should I, at any time:
 - supply untruthful, inaccurate or misleading personal details and information; or
 - be found to be unfit, in the sole discretion of the Producer, as a result of any illness or any other physical or mental condition; or
 - breach any of the Application Rules or behave in a way which the Producer, in its sole discretion, considers inappropriate; or
 - Elect not to enter into the formal written agreement referred to in clause 18 (in the event that I am selected to participate in **TOP COMIC**).

Should the Producer decide, in its sole discretion, not to proceed with **TOP COMIC**, for any reason whatsoever, and then the Producer may in its sole discretion elect to terminate this application without compensation to me.
